What is included in a IAPD report?

Where did this information come from?

The claimants understood the risks, and the investment recommendations were suitable for their stated goals, objectives, and risk profiles. Kalos and I vehemently deny the allegations, however, Kalos has determined, as a business judgment, that it was in the firm's best interests to resolve the dispute rather than incur the time, disruption, and legal expenses associated with a protracted arbitration proceeding. Kalos did not ask me to provide any monies to settle the claim nor did Kalos include me in settlement discussions.
