**Broker Statement**

The Minnesota Commerce Department alleged that I claimed credit for insurance continuing education that was not completed as of the date I submitted my insurance license renewal application on January 31st, 2019. I submitted my renewal application on that date because I expected my last required course to be reported complete by Kaplan that day. Unfortunately, the last 3 credit hour course needed for renewal was not reported by Kaplan by the close of business on January 31st. Since Kaplan did not follow through as expected with something as routine as reporting credits, I feel I was unfairly penalized with an administrative action. I would never claim credit for something I have not completed.
