What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

- information the states require representatives and firms to submit as part of the registration and licensing process, and

Regulator Statement

On December 16, 2022, the Office of Financial Regulation (Office) entered a Final Order adopting the Stipulation and Consent Agreement in the matter of Matthew Bernard Haushalter (Haushalter). Haushalter neither admitted nor denied the allegations but consented to the entry of findings by the Office. The Office found that Haushalter violated Section 517.12(4), Florida Statutes, by rendering investment advice, from a location within Florida, without being registered by the Office. Haushalter agreed to Cease and Desist from violations of Chapter 517, Florida Statutes, and the Administrative Rules adopted thereto, and to pay an administrative fine in the amount of \$17,500. The Office agreed to approve Haushalter's application as an associated person (RA) with Delta Capital Management, LLC effective December 16, 2022.

On March 9, 2020, I started working for Delta Capital Management (CRD 128350) and Delta Securities Company (CRD 130577). I was fingerprinted using the paper fingerprinting forms. I turned those into my Compliance Officer Megan Johnson (CRD 6911479). To my knowledge they were submitted and approved. On January 20th, 2021, Megan emailed me and 2 other individuals that we needed to be fingerprinted again for our RA - Investment Advisor registration with the state of Florida. On January 21, 2021, I was fingerprinted digitally and submitted my TCN to Megan to track. She said she would follow up if anything else was needed. In March of 2022 I logged into FinPro to check what CEs I needed and noticed my status as 'abandoned' for Delta Capital Management. I immediately reached out to Megan who assured me she would take care of the matter and that she thought I was properly registered. When my new registration went abandoned again in May 2022, I called FINRA who directed me to the State of Florida Financial Regulation Office. I spoke with them, and they let me know that Mrs. Johnson never responded to any of the questions about my registration. After this my case was brought to Kaydia Stewart with the state of Florida.

Working with the state of Florida, Delta Capital, Snyderburn, Rishoi & Swann, LLP, and myself we agreed upon terms in the stipulation agreement brought forward by Mrs Stewart. Delta Capital paid the fine for this regulatory agreement through 2 wires to the state. On December 16th, 2022, the office of financial regulation approved my registration with Delta Capital.
