What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations:	Without admitting or denying the findings, Ohlemacher consented to the sanctions and to the entry of findings that he engaged in insurance-related outside business activity (OBA) without providing prior written notice to his member firm. The findings stated that Ohlemacher referred at least eighty individuals - both firm clients and non-clients - to an insurance company not affiliated with the firm's insurance affiliate, earning over \$94,000 in commissions. Ohlemacher never disclosed this OBA in writing to the firm or the firm's insurance affiliate, nor did he receive firm approval for it. In addition, Ohlemacher falsely attested on five annual compliance questionnaires that he had disclosed all OBAs.
