The claim filed and withdrawn in three (3) weeks due to lack of any merit to the customer's claims. I vehemently denied any wrongdoing and asserted that the allegations are completely without merit. The investment about which the customer complained was suitable and was recommended based on the customer's objectives, goals and financial circumstances and was offered only after his review of all material documentation related to the investment. The customer confirmed in writing that he not only received the requisite investment documentation/disclosures, but that he fully understood the characteristics and risks of the investments. At all times, I put the customer's interest first. Upon review, it was determined that Claimant's counsel was misinformed as to the profitable, liquid nature of the specific product. After counsel from my broker/dealer corrected the misinformation, the Claimant withdrew his arbitration.
