**Broker Statement**

In January 2019 I asked for my termination payout amount to be calculated and informed Horace Mann I was ending my association with them. I heard nothing back for weeks until I was informed that an unannounced audit of my office was completed. I had left my office door inside the suite shared with another Horace Mann registered rep unlocked for him to use. Horace Mann had set him up with a non-compliant branch office in my suite so I let him use my office during appointments. Due to my door being unlocked, I was informed I was being discharged for cause and would receive no termination payout per newly amended contract provisions. No client information was ever lost or compromised.
