<b>Broker Statement</b>	15 YEARS AGO,I HAD JUST SPLIT WITH MY FIRST WIFE, AND I WAS CLOSING MY CONSTRUCTION BUSINESS. AT THE TIME I ASKED MY BOOKKEEPER TO CONSOLIDATE MY BUSINESS BANK ACCOUNTS FOR ME.



I HAD 3 SEPARATE BUSINESS ACCOUNTS AT THE LOCAL FIRST INTERSTATE BANK: A PAYROLL ACCOUNT, A TAX ACCOUNT, AND A SAVINGS ACCOUNT. I ASKED MY BOOKKEEPER TO TRANSFER ALL MONIES INTO THE TAX ACCOUNT, THEN CLOSE THE SAVINGS ACCOUNT, AND THE PAYROLL ACCOUNT AFTER THE LAST PAYROLL CHECK WAS WRITTEN, LEAVING ONLY THE TAX ACCOUNT OPEN.

A FEW MONTHS PASSED. DURING THIS TIME, I ONLY ACCESSED THE BANK ACCOUNT WITH THE BANKCARD. UNFORTUNATELY, RIGHT BEFORE TAKING A CONSTRUCTION JOB OUT OF TOWN, I LOST MY BANKCARD. ON MY WAY OUT OF TOWN I WROTE A CHECK FOR \$15.22 FOR GAS AT A MINI-MART IN SCAPPOOSE, IN THE TAX ACCOUNT I THOUGHT WAS OPEN. IT TURNED OUT TO BE THE CLOSED ACCT, AS MY BOOKKEEPER LEFT THE PAYROLL ACCOUNT OPEN AT THE BANK INSTEAD OF THE TAX ACCOUNT. THE OWNER OF THE MINI-MART SAW IT WAS A CLOSED ACCOUNT, AND SENT REGISTERED MAIL TO MY RESIDENCE, BUT I WAS OUT OF TOWN IN PENDLETON, OR WORKING ON THEIR NEW HIGH SCHOOL. THE KEY TO THIS IS, I HAD ONE CURRENT OPEN ACCOUNT AT THE BANK, AND MADE A MISTAKE WRITING A CHECK ON A CLOSED ACCOUNT. I DID NOT INTENTIONALLY WRITE A BAD CHECK.

THE PROBLEM AROSE BECAUSE I WAS OUT-OF-TOWN WORKING, AND COULD NOT RESPOND TO THE REQUESTS FOR INFORMATION IN A TIMELY ENOUGH FASHION, AND HAD NO ONE AT HOME TO NOTIFY ME OF ANY OF THIS.

SO, MONTHS LATER, I CAME BACK INTO THE LOCAL AREA TO VISIT FAMILY AND FRIENDS. I WAS A DESIGNATED DRIVER FOR THE EVENING, TAKING MY FRIENDS HOME, WHEN I ROLLED THROUGH A STOP SIGN IN COLUMBIA CITY, OR, AND WAS PULLED OVER. THE POLICE ARRESTED ME, AND I WAS BAILED OUT IMMEDIATELY. I LATER WENT TO COURT IN SCAPPOOSE, OR, EXPLAINED MY SITUATION AND THE CHARGE WAS DISMISSED AFTER 1 YEAR OF NO SIMILAR OFFENSES. MY BAIL MONIES WERE RETURNED TO ME, MINUS \$75 IN COURT COSTS, AND I HAVE NEVER HAD A SITUATION LIKE THIS AGAIN.
