What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

The advisor denies any wrongdoing. The client agreed on an investment strategy after three face to face meetings. The client consented to the account being invested and was aware immediately that the strategy had been implemented. No concerns were raised until the client complaint sent via e-mail 3 weeks later, during the COVID market drop. The client account was down approx. 6% over the period in question, while the US stock markets were down approx. 20%. The unrealized losses turned to gains within a few months. Following the e-mail complaint, the client insisted on remaining a client, deposited additional funds and referred a sibling.
