IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Employing firm when activities occurred which led to the complaint: CommunityAmerica Financial Solutions

Allegations: Customer alleged unauthorized trading in her brokerage IRA. After several discussions with the customer, she signed an IRA distribution form on 9/28/2017. As had been discussed, this distribution was to satisfy her 2017 RMD as the customer recently turned 70.5 years of age. The distribution request was received and processed, with funds disbursed to the customer's linked credit union savings account on 10/10/17. Unfortunately do to a misunderstanding, the customer was under the impression the forms she signed were actually authorizing a roth re-characterization request for a non-investment account held at her credit union. Because the customer did not understand she had actually signed a traditional distribution request, she was surprised to see the distribution amount, \$7,155.90, appear in her credit union savings account and sent emails to the advisor alleging unauthorized trading. Once distributed, the funds in question never left the customer's savings account. They have been since been pulled back into her brokerage IRA, reversing the distribution.
