IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations:	A municipal bond was solicited by the rep and purchased by the client in two separate accounts in March 2017. In January 2018, a Notice of Non-Payment (of interest) was issued for the series of bonds including the municipal bond in question. Complainant's written complaint expressed displeasure with the performance of the investment and alleged that the municipal bond in question was unsuitable.

Alleged Damages:	\$27,420.25
Alleged Damages Amount Explanation (if amount not exact):	Complainant asked if the firm could offer any financial consideration to both accounts to offset the decrease in price, although no specific compensatory amount was requested. A Notice of Approval of Sale of Substantially All of the Debtor's Assets and Distribution of Sales Proceeds was issued in December 2019, subsequent to firm receipt of complaint. This amount is an estimate based on the amount of principal returned in the client's two accounts on 12/23/2019 as compared to the principal amount originally invested in the municipal bond in question.
