| <b>Allegations:</b>  | Without admitting or denying the findings, Miller consented to the sanctions and to the entry of findings that he changed the representative code on trades, causing the trade confirmations to show an inaccurate representative code. The findings stated that Miller entered into an agreement wherein he agreed to service certain customer accounts, including executing trades for those accounts, under joint representative codes that he shared with a senior team member and a retired representative. The agreement set forth what percentages of the commissions each representative would earn on trades placed using the joint representative code. However, Miller placed trades in accounts that were covered by the agreement using his own personal representative code. Specifically, although the firm's system correctly prepopulated the trades with the applicable joint representative code, Miller changed the code to his personal representative code at the direction of the senior team member. Miller believed that because the senior team member who directed him to change the code was friends with the retired representative that the retired representative had agreed to the changes, but he had not. Miller's actions resulted in his receiving higher commissions from the |



trades than he was entitled to receive pursuant to the agreement. Miller's member firm has already made restitution to the retired representative affected in the transactions and Miller reimbursed the firm \$12,185, which is the approximate amount of additional commissions that he received as a result of his changing the representative code on the trades.

WITHOUT ADMITTING OR DENYING THE FINDINGS, MILLER CONSENTED TO THE SANCTIONS AND TO THE ENTRY OF FINDINGS THAT HE CHANGED THE REPRESENTATIVE CODE ON TRADES, CAUSING THE TRADE CONFIRMATIONS TO SHOW AN INACCURATE REPRESENTATIVE CODE. THE FINDINGS STATED THAT MILLER ENTERED INTO AN AGREEMENT WHEREIN HE AGREED TO SERVICE CERTAIN CUSTOMER ACCOUNTS, INCLUDING EXECUTING TRADES FOR THOSE ACCOUNTS, UNDER JOINT REPRESENTATIVE CODES THAT HE SHARED WITH A SENIOR TEAM MEMBER AND A RETIRED REPRESENTATIVE. THE AGREEMENT SET FORTH WHAT PERCENTAGES OF THE COMMISSIONS EACH REPRESENTATIVE WOULD EARN ON TRADES PLACED USING THE JOINT REPRESENTATIVE CODE. HOWEVER, MILLER PLACED TRADES IN ACCOUNTS THAT WERE COVERED BY THE AGREEMENT USING HIS OWN PERSONAL REPRESENTATIVE CODE. SPECIFICALLY, ALTHOUGH THE FIRM'S SYSTEM CORRECTLY PREPOPULATED THE TRADES WITH THE APPLICABLE JOINT REPRESENTATIVE CODE, MILLER CHANGED THE CODE TO HIS PERSONAL REPRESENTATIVE CODE AT THE DIRECTION OF THE SENIOR TEAM MEMBER. MILLER BELIEVED THAT BECAUSE THE SENIOR TEAM MEMBER WHO DIRECTED HIM TO CHANGE THE CODE WAS FRIENDS WITH THE RETIRED REPRESENTATIVE, THAT THE RETIRED REPRESENTATIVE HAD AGREED TO THE CHANGES, BUT HE HAD NOT. MILLER'S ACTIONS RESULTED IN HIS RECEIVING HIGHER COMMISSIONS FROM THE TRADES THAN HE WAS ENTITLED TO RECEIVE PURSUANT TO THE AGREEMENT.
