What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement	Fidelity recently implemented policies to cut an advisor's pay if they don't have a certain percent of their clients who have gone through the Fidelity retirement planning tool in the past year and if they don't reach out for new sales to AI-generated lists of your clients. I had many clients that requested not to have to go through the tool every year. In addition, many of the clients in the AI-generated list, I had already talked to extensively about the suggested sale. I was attempting to

appease what Fidelity wanted while also doing what was in the best interest of my clients and compliant with the client's preferences. I recognize I should have voiced more strongly my concerns with the policies conflicting with my client's desires. I never made an investment recommendation based on bad data and I never failed to attempt to reach clients for their annual or semiannual review. I've also never had a customer complaint. I deny ever violating investment-related statutes, regulations, rules, or industry standards of conduct. I want to start my own firm with fewer clients where I can truly do what is in the client's best interest.
