This matter involved a security based credit line where the client alleged that his Retirement account was used to secure his credit line and that it created a taxable event. However the client had signed the agreement for the credit line based on the collateral assets in his taxable account. It is not possible to secure a credit line with retirement funds. In fact the client made several withdrawals from his retirement account to fund a refinance of his home. He was told on multiple occasions that moving money out of his IRA creates a taxable event and he should consult his CPA.
