IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

I held a student loan with SoFi Lending at the time of my divorce in 2020. This debt had been incurred during the time of my marriage, but was in my name solely, and was assigned to me as a part of the divorce proceedings. I set up a payment plan to resolve this debt, and made payments faithfully for many months. Unfortunately, I could no longer afford the payment after severing my employment with Merrill Lynch. I stayed in touch with the attorney (Messerli and Kramer) and indicated I would resume making payments after becoming gainfully employed once again. Before this happened, a judgment was filed and I learned of this judgment when a prospective employer (Northland Securities) made me aware it had shown up on a pre-employment credit / judgment search in February 2025. I would have changed this answer on my U4 at that time, but chose not to follow through with employment with Northland Securities. I am changing the answer now, and intend to resume the payment plan to resolve this debt, now that I am employed with Wealth Enhancement Group.
