IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

This disclosure event involves a situation where the Investment Adviser Representative voluntarily resigned, was discharged or was permitted to resign after allegations were made that accused the Investment Adviser Representative of violating investment-related statutes, regulations, rules or industry standards of conduct; fraud or the wrongful taking of property; or failure to supervise in connection with investment-related statutes, regulations, rules or industry standards of conduct.

Allegations: Mr. Reesing was a registered representative of DFA Securities LLC. DFA Securities primary activities are underwriting and distributing US-registered mutual funds and exchange-traded funds that are advised by DFA Securities' parent, Dimensional Fund Advisors LP, an SEC-registered investment adviser. Through routine email surveillance DFA Securities' Compliance team detected emails that that were flagged for possible unacceptable use of company technology. In addition to the initial emails, a further review identified several instances in which Mr. Reesing used his work email account to deliver materials relating to private equity investment opportunities identified by an independent third party to sophisticated investors. The firm did not authorize the delivery of such materials. It was therefore determined to terminate Mr. Reesing's employment and his status as a DFA Securities registered representative.
