IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

AT MY INITIAL COURT APPEARANCE ON OCTOBER 5TH 2006 I WAIVED MY RIGHT TO A PRELIMINARY HEARING AND WAS APPROVED FOR THE PROGRAM. DRUG SCHOOL IS A PROGRAM WHEREBY YOUTHS ARRESTED FOR NONVIOLENT POSSESSION HAVE THEIR CASES POSTPONED IN LIEU OF A COUNSELING PROGRAM WHICH GOES OVER THE LEGAL, PHYSIOLOGICAL AND PSYCHOLOGICAL HAZARDS OF DRUG ABUSE. THIS WAS AN ENLIGHTENING EXPERIENCE, ONE THAT HARDENED MY RESOLVE TO STEER CLEAR OF ILLEGAL DRUGS AND THE PERILS THAT COME WITH THEM. I COMPLETED THE PROGRAM ON 11/4/2006 AND THE CASE WAS DISMISSED IN COURT 1/26/2007.
