What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement FIRM COMMENT: Firm investigation identified that FP assisted client in preparing



and submitting share redemption paperwork once BDC began permitting share redemptions. REPRESENTATIVE COMMENT: The client's complaint is not factual or true. Both the client and her ex-husband bought this non-liquid security, Franklin BSP, on or before July 2014, for their personal retirement accounts through another financial advisor at another firm. This transaction was prior to opening an account with my firm. Per the Divorce Decree, client sought assistance from me to move assets to my firm, which included the security, Franklin BSP. Client's account was opened in the second quarter of 2016. I worked with the client's attorney, ex-husband's attorney, and the other firm to complete the transfer of all noted assets. The client attributes the purchase of the security to me and my firm, which is not factual and a false accusation.
