IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

In June 2024, I met with a client and their spouse to consolidate two IRA accounts from another firm: one in a managed account and one in an annuity. We moved the managed account funds immediately and planned to transfer the annuity after its one-year contract ended in October 2024. On October 14, 2024, we confirmed the account and cash surrender values were the same and decided to proceed with the transfer. The client had a 30-day window to move the funds.

When the client contacted me about surrender charges, I advised them to forward the notice and contact the other firm for possible reinstatement, which was denied. I helped the client write a letter to the other firm and reviewed updates on the Estimated Completion Date.

After filing the Transfer of Assets paperwork, I informed the client that the estimated completion date was October 31, 2024. The funds were not received, and our firm inquired on November 5, 2024, only to learn the paperwork was lost. This resubmission was outside the 30-day window, and the client received a notice dated November 6, showing a zero account balance and a \$7,000 surrender charge.
