What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement It is unclear why Chase has claimed these allegations 4 years after I voluntarily left the company in October 2013. The transaction in question was processed by a teller with review and approval given by the branch manager. My capacity as a private banker primarily focused on deepening client relationships. I had no transaction approval authority and was merely a messenger for transactions to



promote client convenience. As I write this in September 2017, I have never had a client complaint nor been disciplined around sales/ethics or compliance violations in my 10+ years in financial services. I plan to exonerate myself through proper due process.
