What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

I vehemently deny the allegations made by client's daughter. Client's stated goal was to grow the assets for his heirs. The contract provided tax deferred growth, uncapped upside potential (linked to S&P 500), complete downside protection, and no fee. The contract had provisions for CDSC waiver if either spouse had terminal illness, required long term care treatment in a facility, or passed away. LPL annuity review pre-approved the transaction. Client was eligible, per Nationwide, LPL and Trustmark guidelines, to purchase the product for 12+ additional months. Client's daughter made an oral complaint several months after I left Trustmark to accept a new position with another firm. Trustmark appears to have directed the daughter to submit a written complaint, thereby triggering a reporting obligation. Trustmark never contacted me to investigate the allegations. It settled the complaint without my input and withheld the settlement amount from my final paycheck, without discussion.
