What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Employing firm when activities occurred which led to the complaint: Bankers Life Securities, Inc and Bankers Life & Casualty

Allegations: The complaint, written by [Customer's] son, [Third Party], pertains to the recommendation of Bankers Life Securities, Inc. RR Linda Jones that [Customer] liquidate certain securities assets to purchase a fixed annuity issued by Bankers Life and Casualty Company. [Third Party] alleges that RR Jones' recommendation was not suitable as [Customer] utilizes the securities account from which the assets were sold to regularly access funds/income. The complaint further alleges there is no justified tax basis for reallocating the funds from securities to a fixed annuity product.

Product Type: Annuity-Fixed

Alleged Damages: \$20,000.00

Alleged Damages Amount Explanation (if amount not exact): The customer complaint does not allege specific compensatory damages, but requests a return of the customer's principal used to fund the product. In order to receive a refund of the customer's principal, the customer would be required to incur a surrender penalty of 10% of the principal amount, or \$20,000.00
