What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

This Arbitration was commenced on behalf of the claimant by a group of non-lawyers conducting business as Cold Spring Advisory Group. As the respondent brokerage firm's former CCO, I was gratuitously named along with its owners and principals, despite having no nexus to the events supposedly at issue. The firm, upon the advisement of counsel, settled the matter for less than the cost of travel and defense. The firm alone remitted the entire settlement.
