**Regulator Statement**

On January 18, 2017, the Office of Financial Regulation entered a Final Order adopting the Stipulation and Consent Agreement in the matter of Mahesh Bhuta. Mahesh Bhuta accepts and consent, without admitting or denying the findings by the Office. The Office found that Mahesh Bhuta failed to send clients itemized invoices, and comply with the custody and safekeeping requirements of the Florida Securities and Investor Protection Act, Chapter 517, F.S. Bhuta Wealth Management, LLC agreed to cease and desist from violating Chapter 517, Florida Statutes, and the Office's rules promulgated thereunder and pay an administrative fine of \$5,000 jointly and severally with Bhuta Wealth Management, LLC.



## Criminal

This disclosure event involves a criminal charge against the Investment Adviser Representative that has resulted in a dismissal, plea, acquittal or conviction.
