What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

When I recommended the investments in question, the customers and I discussed the investments in detail, and I explained both the risks and the benefits of the investment. I also presented other investments options, which they declined. Following those discussions, the customers decided that the investments fit within their overall portfolio and were appropriate given their objectives and risk tolerance. I was not named as a respondent in this arbitration. I understand that the firm made a business decision to settle the customers' claims to avoid the expense, disruption, and uncertainty of litigation. I was not a party to the settlement agreement, and neither was asked to nor did contribute any amount toward the settlement.
