**Employing firm when activities occurred which led to the complaint:** Change Path, LLC

**Allegations:** On or about March 20, 2018, Mr. Campbell introduced Claimant to another financial advisor regarding Claimant's investment goals. Claimant alleged, through counsel, that it was then advised to invest in 1st Global Capital ("1st Global"), which it ultimately did on or about June 22, 2018. Shortly thereafter, 1st Global filed Ch. 11 Bankruptcy and the SEC filed a complaint against 1st Global for various violations. Claimant asserted the following causes of action: Offer for sale of unregistered security, sale of unregistered security with untrue statement or omission, securities fraud, breach of fiduciary duty, negligent misrepresentation, unlawful acts of advising another, sale of unregistered security, unjust enrichment, and violation of the Washington Consumer Protection Act.

**Product Type:** Promissory Note

**Alleged Damages:** \$250,000.00
