Allegations:	In a written complaint, dated June 18, 2018, addressed to Bankers Life Securities, Inc. (BLS), [REDACTED] stated that, in April of 2018, BLS' Registered Representative Mohsen Babaeian (Babaeian) invested him in an Allianz Variable Indexed Linked Annuity, which [REDACTED] stated he did not want and the policy for which he never received. [REDACTED] alleged he called Babaeian several times and asked to have the policy canceled under the free-look period and to get his money back. [REDACTED] further alleged that, in July of 2018, Babaeian came to his house, despite [REDACTED] insistence in his complaint for Babaeian to not contact him, and [REDACTED] again asked Babaeian to cancel the annuity. According to [REDACTED], Babaeian stated he could not cancel the policy, so [REDACTED] then requested to have the holdings of the annuity reallocated more toward technology. BLS determined that the request to cancel the annuity came after the free-look period expired, but, as a gesture of good-will, Allianz agreed to release [REDACTED] from the annuity under a settlement and release, waiving any surrender penalty.
