IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: The client states that she met with the representative on February 28, 2020 and told him that he "could change the % of allocations within my stock, real estate and bond funds at this time, but not to touch the TIAA Traditional Funds!" The client alleges that changes were made to two of her three accounts where TIAA Traditional funds were reallocated without her authorization and was of the understanding these funds would remain intact. The client alleges had the money been left in the TIAA Traditional account as requested, it would have continued to gain interest during the precipitous fall of the stock market and instead its value has greatly decreased.
