IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: It was discovered that Ms. Mackenzie had been selling fixed annuity products away from Trajan Wealth, LLC while still representing herself as being with Trajan Wealth, LLC. This happened over a roughly 3 year period as the firm has found so far, with the commissions being deposited in to her personal bank account rather than going through Trajan Wealth, LLC. So far it appears that approximately \$3 million in annuities was sold away from Trajan Wealth, LLC, however the internal review is still ongoing. The firm is consulting with outside counsel to assist with the ongoing review and potential litigation proceedings of Ms. Mackenzie.

Firm Statement A re-payment agreement was negotiated between Trajan Wealth and Ms. Mackenzie for her to pay back approximately \$300,000 that she had taken.
