### What is included in a IAPD report?

### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

**Broker Statement**  
 The disclosed events are not related to a client complaint, not financially motivated and not investment related. The alleged violations were of Firm standards, not Industry standards. The business communication disclosure dealt with using a third party translator, the client's son, when communicating with foreign language client. The disclosed prospecting violation involved communication with a prospect who requested a phone call via the firm's website, however the prospect's phone number was on the national Do Not Call registry. A company internal phone system was not used for the requested return call, which triggered a Do Not Call violation, for which the firm said there is zero tolerance.
