What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: Without admitting or denying the findings, Gray consented to the sanction and to the entry of findings that he misappropriated approximately \$138,000 from two elderly customers at his member firm over a nearly two-year period. The findings stated that Gray convinced the elderly couple who, as stated, were customers at his firm to transfer funds from their firm account to their personal banking account held away from the firm. Gray instructed the couple to provide him with blank checks from their personal banking account to allegedly pay fees for their firm accounts. When the customers gave Gray the blank checks, Gray proceeded to make the checks payable to him or to a business with which he was affiliated and then used the customers' funds for his personal use.
