At the time the trades were done on the client's accounts I was not the agent on these annuities. The allocation to money market was made by the previous adviser. I was assigned as agent on the account about a year later, and once I was assigned to the account I reached out to the client on five different documented occasions to review his account and advise him to trade out of money market. I write a note each time I interact with a client, save it in their file, and refer to the earlier notes when I initiate a new contact. As these notes demonstrate, I put forth a strong effort to help the client with his investments. I did not make the trade in question.
