**Broker Statement**

Following a very messy divorce that left me buried in debt, I enrolled in a debt repayment program with PDS Debt/Five Lakes Law Group in April 2024. Through the program, they negotiated repayment terms with my creditors. I pay them a set amount bi-weekly, and they disburse payments to the creditors according to the agreed-upon terms. JPMorgan Chase is the first creditor to be repaid in full, and that debt was satisfied 9/2024.
