### What is included in a IAPD report?

In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

### Where did this information come from?

### Customer Dispute

**Reporting Source:** Individual

**Employing firm when activities occurred which led to the complaint:** MWA Financial Services, Inc.

**Allegations:** Client alleged in April 2015 the representative checked the wrong box as they effectuated the transfer from a Traditional IRA with Franklin Templeton to the client's account with MWA Bank causing the funds to be released from Franklin Templeton as a distribution rather than a transfer from one IRA to another IRA. The client completed bank opening documents for a qualified plan asserting that the funds received from Franklin Templeton were transfers. In January 2016, Franklin Templeton sent the client their 1099 tax reporting forms pursuant to the distributions. This error resulted in unintended tax consequences to the client. Client has alleged that they have paid the taxes on those distributions including penalties for being less than 59-1/2 years of age.
