After it happened, I took the action required to improve my situation and to live in such a way as to ensure that nothing like this happens again. This personal



transformation was already well underway by the time of my court appearance for the infraction. The judge could tell that I was back on the right track and saw fit to dismiss the charge upon successful completion of my probation. I paid a \$300 fine and served one year probation. The matter was dismissed on 1/2/2010 and its disposition was marked as closed as of 3/8/2010.
