On 11/3/2016, the Office of Financial Regulation entered a Final Order adopting the Stipulation and Consent Agreement in the matter of Jose Arquimedes Eustaquio. Mr. Eustaquio neither admitted nor denied the findings but consented to the entry of findings by the Office. The Office found that Jose Arquimedes Eustaquio engaged in securities business from offices within this state without the benefit of lawful registration in the state of Florida pursuant to section 517.12(1), F. S. Mt. Eusaquio agreed to pay an administrative fine in the amount of \$7,500. The Office agreed to approve Jose Arquimedes Eustaquio's application as an associated person (RA) with Wells Fargo Advisors, LLC effective 11/3/2016.
