### What is included in a IAPD report?

### Where did this information come from?

**Allegations:** On September 30, 2024, the Securities Division entered a Statement of Charges and Notice of Intent to Enter an Order to Cease and Desist, Impose a Fine, Disgorge Fees, and Charge Costs ("Statement of Charges") against respondents Pacific Coast Investment Advisors, LLC ("Pacific Coast", CRD# 137963) and its owner Ryan Joseph Murphy, (CRD# 6163513). The Statement of Charges alleges that the respondents violated the Securities Act by acting as an investment adviser and/or an investment adviser representative while not registered to do so. The Statement of Charges gives notice of the Securities Division's intent to enter an order to cease and desist, to disgorge fees, to impose fines, and to charge costs. The respondents have a right to request a hearing on the Statement of Charges.
