### Where did this information come from?

**Broker Statement**

On June 30, 2022, the State of TN opened a post-registration examination. Strategic Wealth submitted 41 client agreements. The state found some inconsistencies such as billing cycle, charges, calculations, etc. The state also found an ineligible "business equity" on its balance sheet from 2019 through June 2022, failing to comply with GAAP standards. Mr. Carmichael was ordered to complete 15 hrs of continuing education and a civil penalty payment of \$20,000
