### **What is included in a IAPD report?**

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

### **Where did this information come from?**

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and

**Broker Statement** I was directed under the supervision of a senior financial advisor to independently consult with two new clients. I completed a review of their current financial situation, made product recommendations and implemented two annuity exchanges that resulted in two annuity sales. At the request of the senior financial advisor the commission was immediately returned in its entirety to the senior



advisor. After Wells Fargo Advisors reviewed the compensation in question, a decision was made to not split the commission and that the senior advisor was deemed entitled to the compensation.
