What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

The Discover Credit Card was a carry over from a small business my wife and I owned from 2001-2006.
My wife had not worked and stayed home with our 4 kids on Long Island for 11 years, In 2007 I had started the commission only job at the Knights and my wife stated working. We were on the upward swing, but after the Super storm Sandy hit in 2012 my business which was tied to the South Shore area of Long Island suffered. My income dropped almost \$30,000 year to year.
