What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

Client approached us with 2 Fixed Annuities that each had limited access to capital plus an 8-year surrender period which would automatically renew after 30 days if not transferred. Client had already been in surrender period for past 16-17 years respectively and was concerned due to her age that next window in 4-5 years would be missed. Client was made aware of additional fees and surrender charges and knowingly accepted them in order to 1 - eliminated recurring surrender charge, 2 - have greater penalty free access to capital, 3 - potential for greater growth via market participation, 4 - maintain death benefit, and 5 - avoid taxes. Client also had \$900,000+ in EE Savings Bonds that had matured, or were close to maturing, and wanted advice in how to go about cashing them. We, together with her Accountant, gave her several redemption scenarios but at no time did we 'make' her cash in the bonds, she alone made the decision to do so. For several years we performed a comprehensive review and service of the client's investments and assets, meeting her financial goals and needs and always acting in her best interest.
