IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement The traditional life insurance policies mentioned were a result of an arrangement between another licensed agent and the Managing Partner of the local office. The licensed agent was taking a temporary leave of absence for personal/family reasons and wanted to have his open cases submitted with the company for him to take over when he returned. I was approached by the Managing Partner to work



with the other agent and serve as the signing agent for the policies. In total there were 4 households and 7-8 life insurance policies involved and no securities products. Each policy was completed and accepted by the client, and each client was provided my name and information as the servicing agent, even though we never met face-to-face.
