What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement When submitting my two week notice of resignation, my employer was unhappy. I have never solicited or sold clients a product without my firm's recommendation and backing. All of the planning tools automatically save to Salesforce, I am unsure how they could suggest my documentation was incorrect since it is tracked automatically. When performing the planning interactions they were exactly as I



was trained and instructed by my supervisors, no client has ever been enrolled in a product that was not in their best interest.
