What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

I was placed on administrative leave pending an internal investigation two days after being approved for medical leave and never heard from anyone in the company for two months and made a decision to resign due to family health reasons and lack of communication from the company during the COVID crisis. Upon submitting my letter of resignation I was contacted that same day by the legal team to wrap up their investigation before I left employment. The firm alleged that I went into the system to notate the completion of three client account reviews without actually completing them. I was able to explain the 3 situations: a client declined a review and then COVID shook the markets so the client went back on that sentiment and we completed the review but Merrill was under the impression



the client declined the review, another client agreed to meet on a Saturday and upon completion of the review the bank closed to which I was unable to put the notes in until the following week and the mismatch of dates was against company policy, and lastly a client and I had a series of meetings including referring his father and son to me and I inputted our review under the wrong date.
