**Employing firm when activities occurred which led to the complaint:** Bankers Life Securities, Inc. and Bankers Life and Casualty Company

**Allegations:** On October 7, 2021, a financial representative (FR) of the Firm received a written complaint, addressed to Bankers Life and Casualty Company (BLC), an insurance company affiliate of the Firm. In the complaint, the client alleged that the FR failed to explain information and provide documentation pertaining to suitability and liquidity when the FR recommended the client use funds from the client's 401k plan to purchase a Guaranteed Lifetime Income Annuity (GLIA) from BLC in April of 2021. The client requested that the annuity be surrendered without penalty. BLC received correspondence on November 7, 2021 that the financial representative was able to address his questions and decided to keep his annuity. BLC determined that the annuity was suitable as it addressed the client's financial goals and objectives. While the annuity sold to client was not a security and was issued by BLC, the Firm is reporting this complaint because the source of funding for the BLC annuity came from the sale of securities recommended by a financial representative of this Firm and client owns an advisory account with the Firm.

**Broker Statement**

I met with the client in November of 2021 to discuss the concerns reflected in his complaint and to revisit our earlier meetings that led to his decision to purchase the GLIA. After that meeting and additional time to review his GLIA policy, the client informed me that he was appreciative of the clarifications, withdrew the allegations of his complaint, and has decided to keep his GLIA for the same reasons he originally decided to purchase it. Namely, his concern with having all his assets at risk in the market at his age and with his timeline of retiring within approximately 5-6 years and his desire to provide the ability to turn on an income that would be guaranteed for life. As he did before, following our most recent meeting, the client agreed that the GLIA fits his needs perfectly.
