What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations:	The Account Owner claims that he transferred his entire \$300,00 Simple IRA to a Roth IRA in 2021 based on the guidance of the RR that the tax liability would be \$30,000. However, upon transfer of the Simple IRA to a Roth IRA, it resulted in a tax liability of approximately \$90,000 and penalties of approximately \$20,000.

Allegations: The client contacted me about a Roth conversion in the Fall of 2021. He wanted to convert some of his \$300,000 SIMPLE IRA. After he contacted me and we discussed it, he asked that I run \$100,000 Roth conversion and illustrate it for him. Our team ran the \$100,000 Roth conversion in eMoney financial software. After meeting with him and walking him through the \$100,000 eMoney illustration he decided that he wanted to do the \$300,000 instead of \$100,000. Early 2022 he contacted me with his CPA and asked why his tax bill was so high. In his complaint to New York Life he stated that he thought he was only going to owe \$30,000 in taxes. I am not sure how he arrived at a \$30,000 tax liability unless he was figuring that amount on the original \$100,000 conversion we presented? According to the complaint there was a tax liability of \$90,000 and penalties of approximately \$20,000. After I received the complaint letter from New York Life they asked me to respond. I responded in the formal time and gave them details on where to find all the documentation in his eMoney account for the \$100,000.00 illustration and where to find the Eagle Strategies email correspondence and parties for the \$100,000 portfolios we worked on. After their review this complaint was denied by New York Life.
