#### Broker Statement

This was a frivolous lien. HDRE was paid in full according to the signed contract. After the fact, HDRE claimed that \$900.00 was left out of the contract for a particular product upgrade. However; the product upgrade was stated and detailed in the signed contract. Legal opinion suggested that we allow it to expire. The lien still exists; however, the lien is only enforceable for 2 years in the state of Nebraska, unless the claimant institutes judicial proceedings on the construction lien within that time. Judicial proceedings were not instituted and HDRE never reinstated the lien.
