IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

NEVER-THE-LESS, THIS IS WHAT HAPPENED TO THE BEST OF MY MEMORY: I AND A FEW OTHERS WENT INTO A LOCAL GROCERY STORE, WHICH HOUSED A SMALL POLICE OUTLET, TO GRAB SOME SNACKS AND CIGARETTES. WHILE I WAS IN LINE TO PAY FOR MY ITEMS, MY ASSOCIATES CAME BY RUSHING TOWARDS THE DOOR AND GRABBED ME. I DROPPED THE ITEMS IN MY HANDS AND HURRIED OUT THE DOOR WITH THEM WITHOUT QUESTION. AT THIS TIME, A COUPLE OF POLICE OFFICERS DETAINED US AND BEGAN TO SEARCH US FOR STOLEN PROPERTY. ALTHOUGH I WAS NOT IN POSSESSION OF STOLEN PROPERTY, IN MY JACKET WAS A SMALL BAG OF MARIJUANA AND A PIPE FOR SMOKING. THE OTHERS, HOWEVER, DID HAVE SOME THINGS THEY HAD STOLEN. CONSEQUENTLY, THE OFFICERS ARRESTED ALL OF US FOR CLASS B MISDEMEANOR SHOPLIFTING AND ME FOR CLASS B MISDEMEANOR POSSESSION OF ILLEGAL SUBSTANCE AND CLASS B MISDEMEANOR POSSESSION OF PARAPHERNALIA. AT THE VERY LEAST, THIS WAS A LOW POINT IN MY LIFE AND I ASSURE YOU THAT IT WAS ALSO A TURNING POINT AS WELL. IT HAS BEEN NUMEROUS YEARS SINCE THIS INCIDENT AND NOTHING LIKE THIS HAS EVER, OR WILL EVER, HAPPEN AGAIN.
