What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement	I categorically deny these allegations and believe them to be false. I never had any dealings with the claimant in this matter. All the client's accounts were handled by another FA and neither I nor my team ever gave any investment advice, made recommendations, nor took any instructions from either the client nor the Claimant. In fact, I never had any conversations or associations of any kind with the deceased client nor her daughter who had POA. This is a family issue over inheritance, and I am being brought into a situation I was not a party to. The allegations alleged against me are factually inaccurate as I was not involved in this relationship nor was I the FA of record at any time the account was associated with UBS. The Firm made the decision to settle with the Claimant. I was not involved in this decision and was not asked to contribute personally as I was not an actual party to the underlying allegations. I am in the process of bringing a FINRA proceeding to have this matter expunged from my record.
