What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement I was working as a non-producing sales assistant for two Senior Advisors at this time. The issue revolved around client signed paperwork. Due to operational inefficiencies and delays at the home office, the back office sat on signed forms for eight weeks. During this delay, the client's spouse passed away. Since the client had authorized action to be taken, and operating under the direction of the Senior Advisors, the original forms were resubmitted to complete processing. Compliance approved this submission.

There was no harm to the client in any way nor was there a complaint. Moreover,



the matter did not involve any securities or securities transactions.

In an effort to protect revenue, the matter was placed on my record. Along with this, I was provided with a severance, a glowing recommendation letter, and all technology equipment from my office. I am happy to provide this documentation upon request.
