IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: The client alleges he was misinformed about his life insurance policy in many ways. The client alleges he did not realize his money would fluctuate, that 55% of his money was in aggressive stocks, that the policy was only guaranteed for 5 years, that he would have to be critically ill for 12 months before entering a nursing home, and that the policy only goes until age 77 when he wanted a whole life policy. The client also alleges that he is too old to have a policy that is so risky at the age of 62. The client also alleges he never had a free look at the insurance policy did not receive a copy of his insurance policy until February 2021.
